Members participate in volunteer and community service led activities within CAN and with partner nonprofit organizations in the community. Members are responsible for client programs throughout the year including family outings at the Zoo, Freedom Waters, Weekend Retreat Beach Bash, Annual Holiday Event, as well as other support services for fundraising events for the charity. Members assist in review, assessment and allocation of sponsorship dollars each school year in accordance with guidelines and procedures for KidsCAN Scholarship Fund. Schools can have chapters or just members. Chapters are led by a school teacher, counselor or activity director as the liaison for the school and charity. These chapters or individual members provide on-going support for Cancer Alliance of Naples in their mission as well as help raise and allocate scholarship dollars to those high school seniors who have been affected by cancer.
